Each Corporate Coalition Member shall identify one in-house/corporate attorney or other employee to serve as the Main Delegate. The Main Delegate is the Company's primary representative within the Coalition, attends the Coalition's Annual Meeting on behalf of the Company, encourages her colleagues' participation in Coalition events, and is eligible to serve as an Officer or on the Board of Directors of the Coalition. The Main Delegate is typically an experienced attorney, with equivalent experience to a Partner or Of Counsel at a law firm and/or leader on diversity initiatives in the company.
